

Rules for Visitors

The Rules for Visitors to the Open-Air Museum of Rural Architecture in South-East Moravia (hereinafter called MVJVM) is issued by the National Institute of Folk Culture, Zámek 672, 696 62 Strážnice. The Rules relate correspondingly to all individuals and legal entities that stay in the open-air museum premises.

I. OPENING HOURS

MVJVM is open for visitors every day from May to October (incl. national holidays) except on Mondays (if a national holiday does not fall on Monday). Out of the season, it is open for cultural and educational events. The NULK director can permit a different operation mode and tours out of the above opening hours exceptionally (a 100 % additional fee to be added to the admission). The visitors will be informed about possible changes in the MVJVM operation in a suitable way.

Entrance ticket sales end 60 minutes prior to closing.

II. TOURS and ADMISSION FEE

1. **Guided theme tours** take place every hour on the hour. The tours do not include all accessible buildings, but they are focused on the following themes:
 - a) human's life (tour every uneven hour),
 - b) human and labor (tour every even hour).
 Minimum number of visitors in a group – 5 person; maximum number of visitors in a group – 45 persons
2. **Guided tours for children** – these tours with their interactive form are intended for booked groups of children.
3. **3.Free tours** are not guided; they take place in July and August every 15 minutes between guided tours. Visitors get a map of the premises and a guide-brochure and they follow the marked tour direction. They can have a look at the accessible interiors over a barrier. Visitors are to leave the area prior to closing.

* **Free admission:** children under 15 years under the above-mentioned conditions, holders of following cards: TP, ZTP, ZTP/P, AMG, Rady galerií ČR, SR, Zväzu múzeí na Slovensku, ICOM, ICOMOS, NPÚ, FOD, Muzejní spolek Uherské Hradiště, Český svaz muzeí v přírodě, teachers accompanying school excursions (2 persons).

Free entrance: on following holidays: 1. 5. | 8. 5. | 5. 7. | 6. 7. | 28. 9. | 28. 10. | International museum day | European heritage days |

- Those who require any kind of discount are obliged to present a valid document.
- Visitors with permanent tickets have to show and stamp their permanent ticket at the MVJVM ticket office, then they will receive a free ticket (for basic admission fee + max. 3 children free of charge)

- Tickets are valid for one admission for one day for all types of tours and programs held in the MVJVM area. Special admission fees are specified for selected cultural and educational events organized by the National Institute of Folk Culture (e.g. International Folklore Festival).
- Visitors or group leaders are obliged to keep the tickets for the entire tour duration; upon wish, they must submit the tickets to NULK guides.
- Lost tickets are not replaced and visitors are obliged to pay a new admission fee.
- Tickets cannot be passed over to other persons if the tour has begun. No refund of purchased tickets.

IV. VISITOR OBLIGATIONS

1. Smoking is prohibited throughout the open-air museum premises.
2. It is not permitted to enter the closed spaces and the inaccessible sections of the premises, marked with a prohibitory sign, to touch the exhibits and furnishing and to damage the NULK property in any way.
3. Visitors are obliged to respect the instructions of NULK responsible persons, especially guides. They may not disturb the tours by loud conversation, use of radios, other technical devices, or mobile phones. It is possible to translate or to comment the guided tour only upon an agreement with the guide, without disturbing other visitors.
4. Impaired persons, persons behaving in an undignified fashion, persons wearing inappropriate (e.g. swimsuits etc.) or heavily soiled garments and persons causing fear they could disturb the tour or be a burden on other visitors are not allowed to enter the open-air museum. If the circumstances that would otherwise not allow a person to enter the open-air museum are exposed only subsequently, such a person will be expelled from the tour without admission fee refund.
5. NULK guides are entitled to expel from the tour persons without valid ticket, persons endangering security of the tour, themselves, or other visitors, and persons who do not adhere to these rules contrary to all notices.
6. Children younger than 10 years must be accompanied by an adult person. The National Institute of Folk Culture is not liable for the security of visitors who leave the marked routes, who do not follow the NULK employees' instructions, or who must be accompanied.
7. Visitors are obliged to inform a NULK employee about any injury they suffered during the tour.
8. Feeding the animals, entering the sheepfolds and pens and fruit picking is strictly prohibited. Intermediate access to animals is at visitors' own risk.
9. Cycling, child's scooters and in-line skating are forbidden in the open-air museum. Visitors may not bring large bags into the museum.
10. Animals can enter the open-air museum (except the buildings) only if they are accompanied by an adult. Animals must be muzzled and kept on a short lead, or placed in a bag or container; they may not be sick, dirty, or aggressive. A person with animal is liable for damages caused by her/his animal and he/she is obliged to clean possible soiling.
11. Photographing, filming, or other picture or audio-visual records in the open-air museum premises (except buildings) are only allowed for personal need of visitors (e.g. family albums etc.). Photographing and other types of records and their use for other purposes (e.g. presentation, advertising, promotion, video-visit-cards, greetings cards, publications etc.) are possible only with prior NULK permission. Use of drones in the MVJVM area is not permitted.
12. The sale of goods is only allowed subjected to the conclusion of a contract with NULK.
13. It is not permitted to organize political meetings and campaigns in the area.
14. The visitors are responsible for damage caused by them in the MVJVM area and they are obliged to compensate the damage in the sense of Civil Code.
15. NULK is not liable for luggage left in the building and vehicles parked in the parking lot.
16. Groups for booked guided tours can be max. 15 minutes late.
17. **Visitors are obliged to leave the open-air museum premises prior to closing.**
